However, a holistic approach is required for the proper restoration and renewal of the building.

The Committee is asked to resolve to invite ClIr Anderson to work with the Clerk to engage appropriate professional advisers, which may include chartered building surveyor, listed building consultant, and/or architect, with the objective of drawing up a scheme of works and costed proposals to put options to the Committee and, if agreed, thenceforth to the Full Council.

The Committee agrees to authorise expenditure up to the current year 2022/23 budget of the Parish Office for the purposes of the emergency repairs and the creation of costed options.
